NOTICE TO SHAREHOLDERS

A jury will hear attorneys' opening statements Monday in the trial of Hadi Matar, who is charged with attempting to murder the novelist Salman Rushdie at a New York lecture.

Rushdie is then due to be among the first witnesses to testify at the Chautauqua County Court in Mayville, New York, a few minutes north of the Chautauqua Institution, a rural arts haven where the writer was stabbed in August 2022.

Matar, 26, can be seen in videos rushing the institution's stage as Rushdie was being introduced to the audience for a talk about keeping writers safe from harm.

Rushdie was stabbed with a knife multiple times in the head, neck, torso and left hand.
