AFFIDAVIT

I, Aarti Sharma, daughter of Shri Dharam Bir Sharma residing at MD-33, Eldeco Mansionz, Sector-48, Gurgaon, Haryana, do hereby solemnly affirm and state as under:-

1. That I am the Finance In-Charge in POWERGRID Khavda IV-E2 Power Transmission Limited, the representative of the Petitioner in the above matter, and am duly authorised to make this affidavit.
2. That the present petition application no. 233/TL/2024 has been filed by the petitioner on the e-filing portal of the Hon'ble commission on 06.06.2024. I say that the present matter was taken up for hearing by this Hon'ble Commission on 22.07.2024 and vide RoP dated 29/07/2024 for the aforesaid hearing, the Hon'ble Commission directed the Petitioner to carry out suitable amendment(s) to the present petition in order to comply with provisions of the Transmission Licence Regulations, 2024.
3. In this regard, I say that the present petition may be amended as below:

i. **Khavda IV-E2 Power Transmission Limited** hereby submits this application under Section 14 & 15 of the Electricity Act, 2003, Central Electricity Regulatory Commission (Procedure, Terms and Conditions for grant of Transmission Licence and other related matters) Regulations, 2024 (hereinafter referred to as "Transmission License Regulations") to establish Inter-State transmission system for "Transmission System for Evacuation of Power from potential renewable energy zone in Khavda area of Gujarat under Phase-IV (7GW) Part E2" on build, own, operate and transfer basis (hereinafter referred to as "the Project") consisting of the following elements:

Note:

- a) The TSP shall implement two complete diameters (1 on Bus Section-I & 1 on bus section-II) at 765 kV level of KPS2 (GIS) consisting of 2 Main Bays & 1 Tie Bay required for completion of diameter (GIS) in one-and-half breaker scheme.
- b) The TSP shall implement five complete diameters (2 on Bus Section-I & 3 on Bus Section-II) at 400 kV level of KPS2 (GIS) consisting of 2 Main Bays & 1 Tie bay required for completion of diameter (GIS) in one-and-half breaker scheme.
- c) Further, TSP of KPS2 shall provide space to carry out the above augmentation work.
- d) 2 Nos. 400 kV bays at Bus Section-I for RE interconnection and 1 No. 400 kV bays at Bus Section-II for RE interconnection are already under implementation at KPS2.
- e) The implementation timeframe: 21 months from date of SPV acquisition.

ii. The Ministry of Power, Government of India, vide its notification no. 3733 [F. No. 15/3/2018-Trans-Part (1)] dated 04.09.2023 has notified REC Power Development and Consultancy Limited (RECPDCL) as the Bid Process Coordinator (hereinafter referred to as BPC) for the purpose of selection of Bidder as Transmission Service Provider (TSP) to establish Inter-State transmission system for "Transmission System for Evacuation of Power from potential renewable energy zone in Khavda area of Gujarat under Phase-IV (7GW) Part E2" (hereinafter referred to as "the Project") through Tariff Based Competitive Bidding process on build, own, operate and transfer basis. A copy of the notifications is enclosed and marked as Annexure-1, (Page 17 to Page 19 of the original petition filed before Hon'ble CERC on 06.06.2024).

iii. That a company under the Companies Act 2013 by the name "Khavda IV-E2 Power Transmission Limited" having its registered office at New Delhi has been incorporated on 05.10.2023 by RECPDCL as its wholly owned subsidiary to initiate the activities for execution of the Project and subsequently to act as Transmission Service Provider (TSP) after being acquired by the successful bidder selected through Tariff Based Competitive Bidding process.



iv. BPC has initiated the selection of successful bidder to acquire the TSP in accordance with the "Tariff Based Competitive Bidding Guidelines for Transmission Service" and "Guidelines for Encouraging Competition in Development of Transmission Projects" issued by Government of India, Ministry of Power under section - 63 of The Electricity Act, 2003 and as amended from time to time.

v. That in the RFP documents, the following is stated

Quote

"The Transmission Charges shall be payable by the Designated ISTS Customers in Indian Rupees through the CTU as per Central Electricity Regulatory Commission (Sharing of Inter-State Transmission Charges and Losses) Regulations as amended from time to time.."

Unquote

Copy of the relevant extract of the RFP document issued by the BPC is enclosed and marked as **Annexure-2**, (Page 20 to Page 21 of the original petition filed before Hon'ble CERC on 06.06.2024) which are integral part of the RFP bidding documents furnished by BPC for bidding.

vi. Subsequent to the process of competitive bidding conducted by the BPC, Power Grid Corporation of India Limited has been declared as the successful bidder. The Letter of Intent was issued to Power Grid Corporation of India Limited on 15.04.2024. A copy of the Letter of Intent (LoI) alongwith the details of Annual Transmission Charges is enclosed and marked as Annexure-3, (Page 22 to Page 28 of the original petition filed before Hon'ble CERC on 06.06.2024).



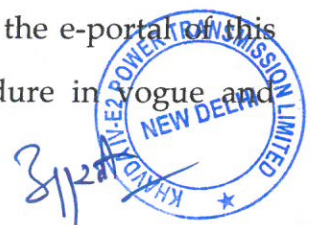
vii. As per the provisions 2.15.2 of Request for Proposal (RFP) and the Letter of Intent issued to Power Grid Corporation of India Limited, within 10 days of issuance of Letter of Intent by the BPC, the Successful Bidder is required to inter-alia provide the Contract Performance Guarantee, execute Share Purchase Agreement & the Transmission Service Agreement and acquire the SPV. Vide letter dated 30.05.2024, the BPC in terms of provision Clause 2.15.2 of RFP has extended the date upto 06.06.2024 for completion of activities by the successful bidder. A copy of the relevant extract of the RFP and the letter from BPC is enclosed and marked as Annexure-4, (Page 29 to Page 30 of the original petition filed before Hon'ble CERC on 06.06.2024).

viii. That in accordance with the LoI, Power Grid Corporation of India Limited on 29.05.2024 has furnished a Contract Performance Guarantee of Rs. 30 Crore (Rupees Thirty Crore Only) in favour of Central Transmission Utility of India Limited (CTUIL).

Power Grid Corporation of India Limited has acquired the **Khavda IV-E2 Power Transmission Limited** on 30.05.2024, after execution of the Share Purchase Agreement, and completing all procedural requirements specified in the RFP documents. A copy of the Share purchase agreement is enclosed and marked as **Annexure - 5, (Page 31 to Page 50** of the original petition filed before Hon'ble CERC on 06.06.2024).

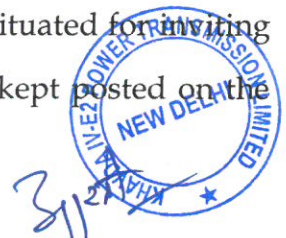
ix. A copy of the Transmission Service Agreement (TSA) entered between CTUIL and Khavda IV-E2 Power Transmission Limited is enclosed and marked as Annexure-6, (Page 51 to Page 186 of the original petition filed before Hon'ble CERC on 06.06.2024).

x. The Applicant shall map Nodal Agency i.e. CTUIL on the e-portal of this Hon'ble Commission at the earliest as per the procedure in vogue and

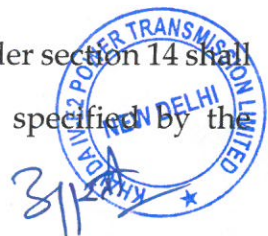


completion of relevant formalities. The Applicant is also sending a copy of the present Petition to CTUIL via e-mail in accordance with the requirement under section 15 (3) of the Electricity Act, 2003 and regulation 5 (3) of Transmission License Regulations, 2024 for its recommendation under section 15 (4) of the Electricity Act, 2003 and regulation 5 (9) of Transmission License Regulations, 2024.

- xii. That a copy of the Application has also been marked to BPC to enable submission of the requisite documents / information by BPC before this Hon'ble Commission regarding the Bidding process undertaken and thereby ensure processing of application.
- xiii. That a copy of the Application has also been marked to Designated ISTS Customers (DICs) and beneficiaries of the Western Region as party to the Petition based on the list of the DICs and beneficiaries furnished by the CTUIL.
- xiii. The application is being hosted on the website and is accessible on www.powergrid.in/subsidiaries in compliance with Regulation 5 (4) of Transmission License Regulations, 2024. It is undertaken that notice of the Application as per Form-II of Transmission License Regulations shall be posted on the e-filing portal of the Commission and also on the Applicant's website in compliance with Regulation 5 (4) of Transmission License Regulations, 2024. Further, in compliance with regulation 5(5) Transmission License Regulations, 2024, the notice of the Application as per Form-II of Transmission License Regulations shall be published in two leading daily digital newspaper, one in English and another in Gujarati i.e., Indian language of the state where an element of the project is situated for inviting comments from general public. The notice shall also be kept posted on the website of the applicant



- xiv. It is further undertaken that the petitioner in accordance with Regulation 5(8) of Transmission License Regulations, 2024 shall submit to the commission in affidavit the details of the notice published, names of the digital newspapers in which the notice has been published, the dates and places of their publication and enclosing the relevant pages of the publication of the notice.
- xv. That a copy of SLD of the transmission scheme is enclosed and marked as **Annexure -7 (Page 187 to Page 187** of the original petition filed before Hon'ble CERC on 06.06.2024).
- xvi. That POWERGRID has acquired the TSP on 30.05.2024 and the same is effective date of the project as per provisions of TSA. The schedule construction period of the project is 21 months. As such Scheduled CoD of the project works out to be 28.02.2026.
- xvii. The applicant is hereby fulfilling the obligations as per 2.15.4 of the RFP documents and all the procedures as stipulated in the CERC (Procedure, Terms and Conditions for grant of Transmission License and other related matters) Regulations, 2024 for grant of Transmission license.
- xviii. Section 14 of the Electricity Act, 2003 (the Act) provides that the Appropriate Commission may, on an application made under section 15 of the Electricity Act, 2003, grant License to any person to transmit electricity as a transmission licensee in any area as may be specified in the License. The word 'person' has been defined in section 2 (49) of the Act to include any company or body corporate or association or body of individuals, whether incorporated or not, or artificial juridical person.
- xix. Section 15(1) of the Act provides that every application under section 14 shall be made in such manner and in such form as may be specified by the



Appropriate Commission and shall be accompanied such fees as may be prescribed. Central Electricity Regulatory Commission has notified Transmission License Regulations (Procedure, Terms and Conditions for Grant of Transmission License and other related matters) and as per Regulation 4 of the aforementioned Regulations, a person selected through the process under the guidelines for competitive bidding is eligible for grant of license.

- xx. That the applicant - **Khavda IV-E2 Power Transmission Limited** incorporated under the Companies Act, 2013 is a 100% wholly owned subsidiary of Power Grid Corporation of India Limited who has been selected on the basis of the Tariff Based Competitive Bidding as per the Tariff Based Competitive Bidding Guidelines for Transmission Service issued by Govt. of India, Ministry of Power and thus eligible for issuance of transmission license.
- xxi. The duly filled Form-I of Transmission license in English and Gujarati in accordance with the Transmission License Regulations, 2024 is enclosed herewith and marked as Annexure-8 (Page No. 13 to Page 17). The revised notice of the application as per Form-I of Transmission License Regulations, 2024 in English and Gujarati shall be posted on the e-filing portal of the Commission and on the Applicant's website in compliance with Regulation 5 (4) of Transmission License Regulations, 2024."
- xxii. That the Transmission Project under reference is governed by the TSA dated 30.05.2024 signed between CTUIL and the Applicant. All the terms of TSA are binding on the signatories of the agreement.
- xxiii. That the Applicant would implement the Project as per the provisions of the TSA including the Articles 16.4 (Parties to Perform Obligations), 5.1 (Construction Responsibilities) and 5.4 (Quality of Workmanship).



xxiv. Further the time over run and cost overrun, if applicable, shall be claimed by the Applicant in accordance with the applicable provisions of the TSA read with the provisions of the Electricity Act 2003, the bidding documents, the regulations of the Central Electricity Regulatory Commission and the exercise of power by Central Electricity Regulatory Commission under the Act and the Regulation.

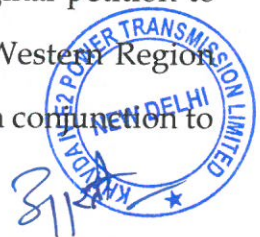
xxv. It is submitted that Section 14 of the Electricity Act, 2003 empowers the Appropriate Commission to grant License.

xxvi. This amended petition shall be read in conjunction to original petition filed before Hon'ble CERC on 06.06.2024 along with all its enclosures.

PRAYER

It is respectfully prayed that the Hon'ble Commission may be pleased to:

- a) Grant Transmission License to the Applicant ; and
 - b) Allow the sharing and recovery of Transmission Charges for Inter-State Transmission System for "Transmission System for Evacuation of Power from potential renewable energy zone in Khavda area of Gujarat under Phase-IV (7GW) Part E2" as per Sharing of Inter-state Transmission Charges and Losses CERC Regulations 2020 and any other amendment thereon issued from time to time by CERC.
 - c) Pass such other order / orders, as may be deemed fit and proper in the facts & circumstances of the case.
4. The petitioner has already mapped the Nodal Agency i.e. CTUIL, on the e-portal of the Hon'ble Commission and forwarded the copies of the original petition to CTUIL, beneficiaries and Designated ISTS Customers (DICs) of Western Region based on the list provided by CTUIL. The amended petition read in conjunction to



original petition filed before Hon'ble CERC on 06.06.2024 along with all its enclosures has also been marked to CTUIL, beneficiaries and Designated ISTS Customers (DICs) of Western Region via e-mail. Vide RoP dated 29/07/2024, it has been mentioned that CTUIL has given its recommendations under Section 15(4) of the Electricity Act, 2003, for the grant of transmission licence to the petitioner.

5. The petitioner has hosted the original application along with notice of its application in Form-I & Form-II on its website. The amended petition along with revised duly filled Form-I of transmission license in English and Gujarati in accordance with the Transmission License Regulations, 2024 shall be hosted on the website of the petitioner and shall also be posted on the e-filing portal of the commission at the earliest.
6. The publication of the notice of Form-II in accordance with Regulation 5(5) of Transmission License Regulations, 2024 in two leading daily digital newspapers in English and Gujarati is being done and the petitioner in accordance with Regulation 5(5) of Transmission License Regulations, 2024 shall submit to the commission on affidavit the details of the notice published, names of the digital newspapers in which the notice has been published, the dates and places of their publication and enclosing the relevant pages of the publication of the notice
7. The revised affidavit in accordance with regulation 17 of the Central Electricity Regulatory Commission (Conduct of Business) Regulations, 2023 is hereby attached as Annexure-Affidavit (Page No. 18 to Page 19).
8. I say that the contents of the above Petition are based on the records of the Petitioner maintained in the normal course of business and believed by me to be true.

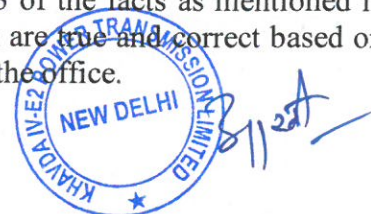

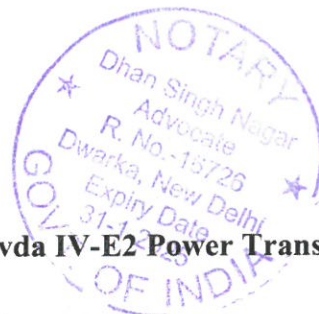
