- 2. Candidates are required to first go through the notification for UGC-NET December 2024 and apply for UGC-NET online. For detailed information on UGC-NET and online application form, candidates may log on to <a href="https://ugcnet.nta.ac.in/">https://ugcnet.nta.ac.in/</a>
- 3. The application process for UGC-NET December 2024 has started from **19.11.2024** and shall remain open till **10.12.2024** and application fees for NET can be paid up to **11.12.2024**.
- 4. Candidates will be required to download their UGC-NET Admit card from the website <u>https://ugcnet.nta.ac.in/</u> as and when intimated by UGC NET. They will also have to retain print out of UGC-NET Application form, Attendance slip and Admit Card. These documents will have the UGC-NET Roll No. of the candidate.

Interested and eligible candidates should apply only through On-line Registration System of POWERGRID. - 5. UGC-NET Roll No.. as appearing on the NET December -2024 admit card needs to be entered carefully in the online application form. No other number should be entered as UGC- NET-December 2024 Roll No. while applying to POWERGRID. Please note that once your application is submitted, no request regarding change in NET Roll Number or Name shall be entertained.
- 6. Before registering and submitting their applications on the website, the candidate should possess a valid E-mail ID, Alternate E-mail ID and Mobile number. This is Mandatory. In case a candidate does not have a valid personal e-mail ID, he / she should create his / her new email ID before applying online. These would be required for accessing information through candidate login during the later stages of the recruitment process. Candidates are advised to keep the e-mail ID and Mobile number entered in the online application form compulsorily active for at least one year.
- 7. Vacancies are for requirement in our Corporate Center, RHQs and site offices. Selected candidates shall be posted for On the Job Training (OJT) and final postings accordingly.

# Candidates are not required to forward the hard copies of applications to POWERGRID.

Candidates will have to bring these documents along with original for verification at the time of document verification / medical / joining, if called for.Candidates belonging to reserved category viz. SC/ST/PwBD are also required to upload their category certificate at the time of online application and later at the time of Document Verification (if called for) in order to avail concession in fee and in service agreement bond amount.

### **SELECTION PROCESS**

- The Selection Process consists of marks obtained in the corresponding paper of UGC-NET December 2024, Document Verification, Behavioral Assessment, Group Discussion, Personal Interview & Pre-Employment Medical Examination.
- Eligible candidates will have to appear for the corresponding paper/ subject of UGC-NET (December -2024), i.e. Subject Code 55 (for HR) / 89 (for Environment Mgt.) / 10 (for Social Mgt.) / 63 (for Public Relations).
- 3. Candidates declared qualified in corresponding paper/ subject of UGC-NET-December 2024 shall only be eligible to be considered for the next stage of selection subject to meeting the eligibility criteria prescribed by POWERGRID. The eligible qualified candidates shall be called for GD & Interview on the basis of their marks in UGC NET December 2024, in the prescribed ratio.

# Qualifying Marks in UGC-NET December 2024 shall be as per the standards set by UGC-NET Conducting authority.

- 4. Qualified candidates shall be short-listed category-wise for Group Discussion & Personal Interview based on their marks in UGC-NET December 2024, in the corresponding paper/ subject and as per the criteria decided by management.
- 5. Candidates shall obtain information about their status through their candidate login at the POWERGRID Online Application System. Shortlisted candidates shall be able to download their interview call letter and other relevant documents through the candidate login.
- 6. Candidates shortlisted for the Group Discussion and Interview shall be required to bring the documents as mentioned in their interview call letter.
- 7. Candidates must qualify in the Personal Interview in order to be considered for empanelment.

#### 9. Empanelment of Candidates:

Candidates shortlisted for GD and interview may have to undergo Psychometric Assessment, results of which shall be used as an input during the interview. Candidates who qualify in the Personal Interview will only be adjudged suitable for empanelment.

Empanelment shall be done on the basis of total vacancies and not separately for POWERGRID & CTUIL(for HR discipline). Operation of panel shall be done on the basis of category wise/ overall merit, based on number of vacancies/ requirement and option / preference exercised by the candidate at the time of applying.

The Offer is issued to the candidate for POWERGRID / CTUIL (as applicable), on the basis of category wise/ overall merit, based on number of vacancies/ requirement and option / preference exercised by the candidate. The offer issued shall be withdrawn and cancelled in case the candidate does not wish to join POWERGRID / CTUIL (as applicable) or decline the offer. No request for change of organization shall be entertained.

Once a candidate gets offer from either POWERGRID / CTUIL, her/his candidature for other organization may automatically be treated as cancelled, even if she/he declines the offer/ does not join the organization.
