In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on 28.08.2024, acquired Bhadla-III Power Transmission Limited, the Project SPV to establish "Additional Transmission System for Evacuation of Power from Bhadla-III PS as Part of Rajasthan REZ Phase-III Scheme (20 GW)", on build, own, operate and transfer (BOOT) basis from the Bid Process Coordinator i.e. REC Power Development and Consultancy Limited.

The project comprises of augmentation of transformation capacity and associated bays extension works at existing Bhadla-III substation, Rajasthan.
