**Sub: Acquisition of Kudankulam ISTS Transmission Limited (KISTSTL) by
POWERGRID under TBCB route.**

Dear Sir,

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on **10.01.2025** acquired **Kudankulam ISTS Transmission Limited**, the Project SPV to establish “Transmission System under ISTS for evacuation of power from Kudankulam Unit - 3 and 4 (2x1000 MW)”, on build, own, operate and transfer (BOOT) basis from the Bid Process Coordinator – PFC Consulting Limited (PFCL).

The project comprises construction of 400kV Transmission line between KNPP 3 and 4 Tuticorin-II traversing in the state of Tamil Nadu along with the terminal equipment at Tuticorin-II S/s.

Brief details of any governmental or regulatory approvals required for the acquisition;	KISTSTL was incorporated on 28/06/2024 by the Bid Process Coordinator as per the “Guidelines Encouraging Competition in Development of Transmission Projects” and “Tariff based Competitive-bidding Guidelines for Transmission Service” notified by Ministry of Power (MoP). Requisite approvals were obtained by the Bid Process Coordinator for transfer of KISTSTL. Approvals for Grant of Transmission License and Adoption of Transmission Charges are to be obtained from Central Electricity Regulatory Commission by KISTSTL after the acquisition by POWERGRID.
6.	Indicative time period for completion of the acquisition;	KISTSTL has been acquired as per the timelines furnished by Bid Process Coordinator.
7.	Consideration - whether cash consideration or share swap or any other form and detail of the same;	Cash consideration as detailed at S. No. 8 below.

Cost of acquisition and/or the price at which the shares are acquired;	KISTSTL has been acquired for an aggregate value of about Rs. 7.44 Crore including 10,000 equity shares at par at Rs. 10 each along with assets and liabilities of the KISTSTL as on the acquisition Date (10.01.2025). However, the acquisition price is subject to adjustment as per the audited accounts of the KISTSTL as on the acquisition date.

Brief background about the entity acquired in terms of products/line of business acquired, date of incorporation, history of last 3 years turnover, country in which the acquired entity has presence and any other significant information (in brief).	The entity i.e. KISTSTL shall be engaged in the business of transmission of power. KISTSTL was incorporated on 28/06/2024 by Bid Process Coordinator. The entity is yet to start commercial operation, as such no turnover has been recorded during last 3 years. KISTSTL will be operating in India.
